## TRANSPORTED COOLED SEMEN AGREEMENT

I, \_\_\_\_\_ (mare owner) have agreed to breed \_\_\_\_\_  
(name and registration number of mare) to HAVIN A RECORD YEAR, REG. NO. 1040799, in the 2019 breeding season and hereby request that cooled semen be transported for said breeding under the following terms and conditions:

1. The first collection is included with each paid breeding, freight will be paid by DOUBLE L, (overnight UPS or FEDEX, USA only).
2. After the first collection, there will be a collection charge of \$285.00 per shipment, freight included (Shipments within the United States). Shipped semen picked up at the farm is \$185.00
3. The stud fee of \$1000.00 must be paid in full on or before execution of this agreement .
4. A copy of the mare's registration papers should be received by the stallion owner before semen will be shipped to mare owner. Mare owner recorded on registration papers will be used on Stallion Breeding Report.
5. Reservation for shipped semen:
  - a. Fresh chilled semen will be collected and shipped on breeding days, this will be on an every other day basis, Mon, Wed, Friday, however, every effort will be made to accommodate the mare owner.
  - b. All semen orders must be received by noon the day of the requested collection date. Late orders will be filled if possible but not guaranteed.
  - c. Breeding Manager would appreciate notification when the mare first shows signs of heat.
6. Mare must be inseminated on the date of delivery of the semen by a licensed Veterinarian.
7. Mare owner agrees to have mare examined by an early ultrasound scan 15 days after the last day inseminated and notify the Breeding Manager of her pregnancy status. It is suggested that the mare be pregnancy checked again at 45 days by manual palpation.
8. The mare owner is responsible for all container shipping charges TO and FROM the breeding farm.
9. The semen container must be returned to Double L Paint Horses the day after the mare is inseminated.
